

PRIVACY STATEMENT

General

Privacy is a valuable commodity. Van Keulen Interieurbouw B.V. respects your personal data and is responsible for ensuring that the personal data that is provided to us, or that we acquire otherwise, will be dealt with confidentially. With this privacy statement we inform our website visitors, customers and other business contacts regarding the information that we collect and the manner in which we use this information.

Personal data

a. Website visitors

We do not use 'cookies' on our website. Therefore no small text file will be saved for example on your computer, tablet, or smartphone.

b. Customers:

Van Keulen Interieurbouw B.V. processes the personal data of persons employed by the customers or associated with the customers. We process this data on the basis of an agreement that we have with you, for conducting the administrative records forming part thereof, for audits and for the implementation of applicable legislation and regulations. In all other cases we will expressly request your permission to be allowed to process your personal data.

c. Other business contacts

Van Keulen Interieurbouw B.V. can process personal data of (future) business contacts of Van Keulen Interieurbouw B.V. We process this data for deliveries and orders or for the purchase of services on the basis of an agreement that we have with you, for conducting the administrative records forming part thereof, for audits and for the implementation of applicable legislation and regulations. In all other cases we will expressly request your permission to be allowed to process your personal data.

d. Job applicants

Van Keulen Interieurbouw B.V. processes the personal data of job applicants. After the end of the selection procedure we will remove your data within 4 weeks. When providing express permission, this can be extended for a period not exceeding 1 year after the conclusion of the selection procedure.

Personal data security

Van Keulen Interieurbouw B.V. highly value the security and protection of your personal data and, taking state of the art technology into consideration, uses applications and systems that are secure in conformity with the requirements of current legislation and regulations for the prevention of loss of data or unlawful processing thereof.

Sharing personal data

We usually receive personal data from you personally, for example via websites used by Van Keulen Interieurbouw B.V. and by email or telephone. In specific cases we also acquire your personal data from third parties. We only provide your personal data to third parties if this is made compulsory for us, or if this is necessary for our provision of service. For example, sending (digital) documents/documentation (that include personal data) to parties. We do not provide personal data to third parties without express permission from the person involved. We do not provide your data for commercial purposes or to charities.

We use services of third parties, such as IT suppliers for our website and the accounting system. In that context we provide personal data to these third parties. A processing agreement is concluded with these third parties, as a result of which these third parties are also obliged to comply with the GDPR. These third parties are only permitted to process your personal data for the benefit of Van Keulen Interieurbouw B.V. and not for the purposes of these third parties.

Our website can contain references to other websites, for example by means of a hyperlink, banner or button. We are not responsible for any privacy policy of other websites or sources stated on our website.

Retention periods

Van Keulen Interieurbouw B.V. does not save the personal data that will be processed for any time longer than is necessary for the purposes set out in this statement for the data processing, or required by legislation and regulations.

Your rights

You can make a request for access to, adjustment, or removal of your personal data or withdrawal of permission provided earlier via the email address info@keulen.com. Within four weeks after receipt of your request you will receive a further message from us. Circumstances can occur in the course of which our office cannot or cannot completely implement your request. For example due to statutory retention periods.

In order to be certain that we provide the personal data concerned on the basis of your request to the correct person, we ask that you submit for verification a copy of a valid passport, driving licence, or identity document, with the passport photo and BSN number blackened out. Van Keulen Interieurbouw B.V. only deals with requests related to your own personal data.

Changes to the privacy statement
